MINUTES of the COUNTRY CLUB HOA BOARD MEETING - 09 October 2018

President Steve Paradis called the meeting of the CCHOA Board to order at 5:35PM on 9 October 2018 at the Ascension Lutheran Church, 2505 North Circle Drive, Colorado Springs, CO 80909.

Present: Janice Marie-Gallof, Marty Henderson, Dave May Vicki Tostanoski, and Steve Paradis. John Cunning, Sandy Gallof, Anne Hudnall and Hayden Gregory were absent.

MINUTES of the PREVIOUS MEETING:

a. The minutes of the previous regular Board meeting held on 11 September 2018 were presented. Dave motioned that the minutes be approved. Marty seconded the motion. The minutes were approved unanimously.

FINANCIAL REPORT (Marty Henderson):

- a. The Treasurer's Financial Statements for the period ending 30 September 2018 are provided in Attachments 2 through 4
- b. Marty reported we had 10 more residents pay their dues in September to receive the HOA trash service, all of whom paid via USPS. That brings us up to 58% participation in the HOA.
- c. Marty reported the financial audit for 2017 was conducted on 9/12/2018. Tom Waugh, Dave Corrow and Hayden Gregory completed the review with no findings. The only item noted was that in the future a budget should be created in advance. No budget was prepared for 2018.
- d. Janice motioned that the Financial Report be approved. Dave seconded the motion. The Financial Report was approved unanimously.
- e. Steve noted that he needs to submit receipts for the two newsletter mailings this year.
